

SUPPLEMENTARY REGULATIONS

NSW STATE CHAMPIONSHIP MOTORKHANA – Round 8

1. This event will be known as "NSW State Motorkhana Round 8" hereafter referred to as "The Event".

Authority: The Event will be conducted under FIA International Sporting Code including Appendices, the National Competition Rules (NCR) of Motorsports Australia, the National Motorkhana Standing Regulations published by Motorsport Australia, the NSW Motorkhana Appendices, Motorsport Australia Passenger Ride Activity Policy (MSPRA), these Supplementary Regulations and any Further Regulations which may be issued. This Event will be conducted under and in accordance with Motorsport Australia OH&S, Safety 1st, Legal and Integrity and Risk Management Policies, which can be found on the Motorsport Australia website at www.motorsport.org.au/.

2. Motorsport Australia Permit No 222/0409/03

The Motorsport Australia permit will be displayed at the start of the event.

10. Event Schedule:	Start time: 9:30 am	Finish time: 4:00 pm.	
11. Entry Fee:	Adults \$80, Juniors \$	\$40	

Event entry is <u>only</u> via Motorsport Australia<u>Event Entry</u>. Entries will <u>**not**</u> be accepted on the day.

12. Entries

- a) Maximum number of entries for the Event: 40 Reserves: 5
- b) Opening Date: Saturday 13th August 2022
- c) Closing Date: 9:30am Sunday 4th September 2022
- **d)** A NSW Motorkhana Championship competitor is defined as an entrant in a previous state motorkhana round in 2022.
- e) Entries are open to all members of Motorsport Australia affiliated car clubs.
- **f)** Preferential opening date: Saturday **13th August 2022** for NSW Motorkhana Championship competitors.
- g) General opening date: Monday 21st August 2022 for all competitors.
- h) Should the maximum number of entries be exceeded then preference will be given to NSW Motorkhana Championship competitors up to Monday 21st August 2022 and then in order of entry date received irrespective of championship status.
- i) Entries must be lodged on the event entry form with the event secretary via the Motorsport Australia <u>Event Entry</u>.
- **j)** Entries from people under 18 years of age must be counter-signed/consented by a parent or legal guardian.
- **k)** Maximum number of drivers per vehicle is four. (4). Competitors are reminded to ensure vehicles are santised between runs.
- I) If an entrant advises the event secretary that he/she is unable to attend the event, a request for a refund can be made through the "member portal" on Motorsport Australia Website. A refund will be at the discretion of the Event Organiser.
- **m)** Entries may be refused in accordance with the NCR's of the current Motorsport Australia Manual.
- **n)** Competition numbers shall be allocated at the discretion of the Event Secretary in order of receipt.

13. Tests:

Minimum of 6 tests as per motorkhana code. Two runs at each test with the fastest time used in the results.

Drivers will be advised of the selected tests before the event starts.

14. Minimum licences:

Drivers must have a current Motorsport Australia Speed Licence or Junior Speed Licence (or superior) and a current membership of a Motorsport Australia affiliated car club. Due to COVID-19 restrictions, licence currency will be verified electronically prior to the Event. Drivers must present car log book (if issued) for stamping by the Chief Scrutineer.

15. Juniors:

Junior drivers (i.e. not less than 12 years and under 18 years of age as of the date of the event) will be required to carry a parent or guardian as a passenger ("Observer") until the Clerk of the Course is satisfied with their driving capabilities. That parent or guardian must be the person who signed giving consent for the junior on their Motorsport Australia

16. Scrutineering:

Due to COVID-19 restrictions <u>there will be no pre-event scrutineering at the Event</u>. The Self Scrutiny Checklist form and the Event Entry Self- Scrutiny Statement of Vehicle Compliance (TSP03EE) scrutineering declaration **must be completed online as part of the pre-event documentation and emailed to the Event Secretary.**

A self- scrutiny vehicle safety checks-Autotest must be performed by the competitor and driver using the Self- Scrutiny Checklist at the circuit prior to the competition.

Please note that scrutineers will conduct spot checks through the day whilst maintaining distancing and non-contact protocols.

- a) Start time: 8:00 am Finish time: 9.30 am
- **b**) Location: Scrutiny area near event admin shelter
- c) All apparel shall comply with Schedule D of the current Motorsport Australia Manual of Motor Sport
- **d)** A helmet is not mandatory except for drivers of Motorkhana Specials. Where a helmet is worn it must comply with Schedule D of the current Motorsport Australia Manual.
- e) All cars must comply with Schedule A and Group 4H of the current Motorsport Australia Manual.
- f) Cars must be adequately muffled to comply with noise restrictions.
- g) Fuel must be in accordance with Schedule G of the current Motorsport Australia Manual.
- h) Any camera or video recording device mounted in or on a competition vehicle must be approved by the Chief Scrutineer. Cameras mounted on specials or on the exterior of other vehicles must have a secondary restraint if the primary mount is by suction cup(s).

17. Classes:

Motorkhana Classes:

Class A Production Vehicles Wheelbase up to 2150mm Class B Production Vehicles Wheelbase 2151 to 2390mm Class C Production Vehicles Wheelbase 2391 to 2574mm Class D Production Vehicles Wheelbase 2575mm and over. Class F Front Wheel Drive Specials Class G Rear Wheel Drive Specials Class H Production Vehicle Based Specials Non production 4WS (4 Wheel Steering) and 4wd vehicles are not permitted

Motorkhana Categories: (Nomination in a category does not preclude a driver from competing for class awards) Category J Juniors Category LP Ladies in Production Vehicles Category LS Ladies in Specials

18. Results, Prizes and Trophies:

1st Outright, 1st in each Class (minimum 3 entries in Class), 1st in each Category (minimum 3 entries in Category). All awards are mutually exclusive. Results shall be determined by the lowest aggregate of elapsed times on the tests completed, inclusive of penalties. Timing shall be to 0.01 second.

19. Drivers' Briefing

Due to COVID-19, there will be no "planned" Drivers' Briefing at the event. Drivers Briefing notes will be distributed electronically to all Drivers prior to the event and acknowledgment of them must be submitted to the Event Secretary electronically by no later than 2 days after

the Event Closing Date.

20. Authority of officials:

Any competitor not following a reasonable instruction by an official during the Event may be excluded.

All Officials will be Judges of Fact in accordance with National Motorkhana Standing Regulations and the NCR.

21. Insurance:

Certain public, property, professional indemnity and personal accident insurance is provided by Motorsport Australia in relation to the event. Further details can be found in the MOTORSPORT AUSTRALIA Insurance Handbook, available at <u>www.Motorsport</u> <u>Australia.com.au</u>.

- 22. Start and Finish Procedures shall be in accordance with Article 13 of the National Motorkhana Standing Regulations. Running order shall be at the discretion of the Clerk of Course.
- **23. Protests** Any protest must be in accordance with the NCR.
- 24. **Postponement / abandonment / cancellation.** The organisers reserve the right to postpone, abandon or cancel the Event in accordance with the NCR's of the current Motorsport Australia Manual.
- 25. Alcohol, Drugs and Other Substances: The holder of a Motorsport Australia Licence (or a Licence issued by another ASN) may be tested for the presence of any drug or other banned substance and subject to a penalty for a breach of the Australian National Anit-Doping Policy and /or the Motorsport Australia Illicit Drugs in Sport (Safety Testing) Policy at www.motorsport.org.au

Consumption of alcohol in the paddock, pits or any other Reserved Area is prohibited until all *Competition* is concluded each day. The holder of a Motorsport Australia Licence (or a Licence issued by another ASN)_ may be tested for the presence of alcohol by a Motorsport Australia Accredited Testing Official (CATO) in accordance with the Motorsport Australia Alcohol Policy at www.motorsport.org.au

25. Refreshment facilities: The Garage.

- **27. Fuel** is available at the venue.
- **28.** Additions and/or alterations. Any additions and/or alterations to these Supplementary Regulations will be notified to all entrants in Further Regulations or during the Drivers' Briefing.

29. Passengers

Due to COVID-19, passengers will not be allowed to accompany a driver as a trainer or an observer, with the exception of juniors (refer to Clause 15). As per MSPRA Policy all Passengers must complete a Passenger Ride Entry form.

Note: Passengers must wear the same safety apparel as the driver which is appropriate for the class the vehicle is being competed in. The passenger must be restrained as required for each Automobile with consideration for their physical attributes. Vehicles shall only carry one Passenger at a time.

30. COVID-19 Special Conditions

- a) Under no circumstances may anyone attend the Event if any of the following apply:
- i. Have any symptoms consistent with COVD-19 such as higher temperature, respiratory issues, shortness of breath, sore throat, lack of sense of small, fatigue
- ii. Have tested positive to COVID-19 within the period advised by NSW Health leading up to the event.
- iii. Social distancing as required by Governments is to be maintained.
- b) Spectators are permitted at the Event in designated areas.

c) Sharing of tools, equipment and apparel is to be avoided. If sharing is unavoidable, the equipment must be cleaned prior to use by another person.

- d) The sharing of food is to be avoided.
- e) Social distancing as required by Governments is to be maintained.
- f) Comply with any requests by the COVID-19 Event Checker. Note that the event will not commence without the COVID-19 Event Checker's authorisation.
- i) Entrants and pit crew must acknowledge the COVID-19 venue plan for the event
- j) If more than one driver is sharing the car, then touch surfaces within and without the car must be wiped down between driver changes.
